 - b) The firm that has completed three works with equal cost of 40% value of the work or two works with the equal cost of 50% value of the work or one work with equal cost of 80% value of the work, during the last seven years and furnishes the performance certificate for the same shall be eligible for issue of the tender form.
3. The tender form will be received by the undersigned in his office on **05.04.2011 at 3.00 p.m.** through Registered/ Speed Post and will be opened on the **05.04.2011 at 4.30 p.m.** in the presence of the tenderers or their representatives.
