Deptt. or two similar nature of work with equal cost of 60% value of the work or one similar nature of work with equal cost of 80% value of the work during the last seven years ending last day of the month previous to one in which the application are invited and furnishes the performances certificate for the same shall be eligible for issue for the Tender form.
