Deptt. or two similar nature of work with equal cost of 60% value of the work or one similar nature of work with equal cost of 80% value of the work during the last seven years ending last day of the month previous to one in which the application are invited and furnishes the performances certificate for the same shall be eligible for issue for the Tender form.
3. Pre tender meeting of firms that will be issued tender forms will be held on 09.01.2015 at 5.00 p.m. in the office of Executive Engineer-I
4. The tender form will be received by the undersigned in his office on 12.01.2015 upto 3.30 p.m. and will be opened on at same time in the presence of the tenderers or their representatives.
