- 4. The tenders will be opened in the meeting of JPC in presence of tenderers or their representatives who may like to be present at that time.
- 5. Panjab University does not take any responsibility for any postal delay in delivery by Registered/Speed Post or lost in transit of the tender form. No tender will be entertained by hand/courier/ Ordinary post.
- 6. The firm/contractor that has completed three works with equal cost of 40% value or the similar nature of work with one work in Govt. Deptt. or two works with equal cost of 60% value of the work or one work with equal cost of 80% value of the work, during the last seven years and furnishes the performance certificate for the same be eligible for issue of the tender form.
