**NOTICE INVITING TENDERS**

Sealed tenders on plain paper are hereby invited from the interested parties for the sale of fruit crop of about 400 nos. Mango (Dusheri) fruit trees around boys hostel no.1,2,3,4 & 5 and also the fruit crop of about 150 nos. of Desi mango trees in the Panjab University Campus, Sector-14, Chandigarh for two seasons i.e. for the years 2016 and 2017.

The sealed tenders shall be received by the undersigned in his office up to 3.30 p.m. on 11.05.2016 by **registered post or speed post** and shall be opened at a suitable date as decided by the authorities after 11.05.2016 in the presence of the tenderers or their authorized representatives who may like to be present at that time.

Only the tenders accompanied with the earnest money at the rate of 2% of the reserve price of the tender will be entertained. The earnest money can be deposited with the undersigned in the shape of demand draft in favour of the Registrar, Panjab University, Chandigarh.

2. Panjab University does not take any responsibility for any postal delay in delivery by Registered/Speed Post or lost in transit of the tender. No tender will be entertained by hand/courier/ Ordinary post.
3. If the date of submission of tender falls on holiday/declared holiday then next working day with same timing will be considered for submission of tender.
4. No tender unless accompanied with the earnest money shall be entertained
5. The highest tenderer shall have to deposit Rs.10,000/- as security within 2 working days of the opening of tenders.
6. No tree shall be damaged in any way.
7. Fruit shall have to be removed latest by 31<sup>st</sup> of July of respective year.
8. The undersigned reserves the right to accept or reject any tender without assigning any reason.
9. In case of any dispute the decision of the undersigned shall be final
9. No claim shall be entertained for any loss to the fruit due to natural cause or otherwise. Force majeure condition shall be applicable.
10. Full amount of the highest bid shall have to be deposited with the State Bank of India (Sector-14 branch) of the University within 2 days of the opening of the tenders.
11. The mango fruit can be plucked only after the approval of the allotment by the Competent Authority.
12. Any more information if required can be obtained from the office of the undersigned on any working day, during working hours.
13. The Tenderer who have already applied in response to Notice Inviting Tender no. 430-39/Hort. dated 06.04.2016 floated by this office need not apply afresh. Their previous tender will be considered as such.
