#### **TERMS AND CONDITIONS**

### for Various Types of Printing/Binding Machinery

- 1. Sealed Tenders conspicuously marked 'Tender for Machinery' and duly addressed to the Registrar, Panjab University, Chandigarh (by designation and not by name), are invited in Two-Bid system so as to reach in the office of the undersigned up to <u>03.00 pm</u> on 22-03-2012 in a strong cover and securely fastened with a distinctive device.
- 2. The sealed outer cover of the Tender must contain two separately sealed envelopes within. The first envelope should be marked 'Technical Bid for Machinery etc.' and the second envelope should be superscripted as 'Financial Bid for Machinery etc.' Furthermore, the envelope of Financial Bid must contain separate sealed envelop(s) for each item quoted by the Firm.
- 3. The <u>Technical Bids</u> of the Tenders received in time only, will be opened at 03:30 pm. On 22-03-2012. The Technical Details submitted by the Firm shall be subject to verification, which can be done before the allotment of the work. The <u>Commercial Bids</u> will be opened on a date/time to be specified/intimated later on to only such Firms which will fulfill technical requirements as mentioned in the Tender Document. <u>The Tenders/Bids etc. shall be opened on scheduled date/time in the presences of those Tenderers who may wish to be present</u>. In case tender opening date falls on a holiday subsequently declared by the Govt., the Tenders/Bids shall be opened on next working day of already fixed/conveyed date at the scheduled time.
- 4. TECHNICAL BID must contain following documents. Any Technical Bid not accompanied by these requirements is liable to be rejected:-
  - (i) Earnest Money i.e. Rs. 25000/- in either of form as per para 12 hereto after;
  - (ii) Central sales tax / sales tax number;
  - (iii) An attested copy of Income Tax Clearance Certificate of preceding year;
  - (iv) Certified Balance Sheet showing Turn-over of the Firm in preceding 3 years;
  - (v) Original manufacturership / authorized dealership' certificate showing existence of Firm and indigenously manufacturing of the machine & equipment for last 3 years;
  - (vi) Authorization Letter from manufacturer, if Tenderer is authorized dealer agent;
  - (vii) List of establishments (local/surrounding) wherein offered machines/equipments are installed;
  - (viii) List of service centers existing in Punjab, Chandigarh, Haryana & Delhi;
  - (xi) Supported by literature, give Technical detail of offered machines/equipments as per below:

Note:- Upon direction, the demonstration of quoted Machinery & Equipment shall be arranged by the Tenderer at his cost and responsibility.

- 5. First of all only Technical Bids shall be opened on date & time as specified in para 3 above. In any case, the Technical Bid must not contain rates else such Tender of the Firm shall be rejected out-rightly.
- 6. FINANCIAL BID of only those firms shall be considered whose specifications/features offered in their Technical Bids and the demonstration of their machines/equipments is found to meet minimum technical requirement of Schedule 'A'.
- 7. Financial Bids must bear the rates quoted by the Firm and other conditions/offers related to the rates aspects. The rates should be F.O.R. destination/premises of Panjab University Press, Chandigarh and inclusive of all incidental charges viz. packing, forwarding, freight, loading and unloading, transit insurance, installation of machine/equipment at related Panjab University Press, training of operatives and servicing/handling charges during the entire guarantee period. The rates must be inclusive of all taxes, sales tax / VAT etc .if any. The rate of sales tax / central sales tax/ VAT or any other applicable tax/levy should be mentioned specifically else nothing shall be paid on such counts later on.
- 8. In case the machine/equipment is dispatched by Road, the delivery shall be F.O.R. premises of the Panjab University Press and in that case risk to the point of delivery shall be of the supplier Firm. The toll tax and octroi if any has to be paid by the firm.
- 9. Rates should be quoted both in figures as well as in words the attached form Schedule 'A'. All columns of the Tender must be properly and exhaustively filled in Words 'not quoted' must be put across against item for which Firm is not interested.
- 10. Tendrer must initial any erasing/alteration that may have been made in the Tender.
- 11. If you are a partnership Firm (i.e. if you have a partner or partners), each of you must sign and mark the Tender. If any partner be absent, his duly appointed nominee will sign these documents. In case of company, the Tender must be executed in the manner laid down in the said company/articles of association. The signature(s) on the Tender would be deemed to be authorized signature(s).
- 12. Technical Bids of the Tender should be accompanied by Earnest Money i.e. Rs. 25000/- (Technical Bid Performa) of each machine/item. Without requisite Earnest Money the Tender will not be considered. Earnest Money should be in any of the prescribed manners Deposit-at-call receipt/pledged FDR in favour of 'Registrar Panjab University , Chandigarh' (by designation only and not by name). Cheques, currency notes/cash will not be accepted and such Tenders shall be rejected. No Security Deposit that may have been furnished by the Tenderer in connection with any previous contract (or any other account) would be accepted as Earnest Money in any case.
- 13. If your rates are approved, you will be informed in writing whether 'Acceptance' of your Tender is in whole or in part. Till then, you have no right to assume that your rates have been accepted and in case of disregard, no claim for compensation shall be entertained.

14. The Security Deposit furnished must be in any of the prescribed manner i.e. deposite-at-call

receipt/pledged FDR/Bank Guarantee etc. but excluding cheques/ currency note or cash which shall not

be accepted. In case of bank guarantee, it should remain open till the completion of contract period,

final payment and guarantee period of the machine & equipment, as the case may be. If you are a

successful Tenderer your Earnest Money will be released as soon as the Security Deposit has been

furnished, unless it is used as part of the security Deposit on written request by the approved Firm.

Earnest Money of unsuccessful Tenderers unless forfeited under clause 16 below will be returned

immediately after rejection of their Tenders. Security Deposit shall be returned after the expiry of

guarantee period and after submission of No Demand Certificate on Judicial paper by the Firm in the

prescribed proforma.

15. The rates quoted in the Tender shall hold good upto One month or so shall extend this period if request

is made by the Department before 31-03-2012 and shall not be subject to change in rates due to

fluctuation in prices. If the Tender is withdrawn before this period, or if you do not deposit the Security

Deposit in accordance with clause 14 above, without prejudice to any other right which the Panjab

University may have, your Earnest Money will be forfeited. The accepted rate of successful Tender(s)

shall remain in force by that time as specified in the supply order.

16. The approval or rejection of Tender rests with the Registrar Panjab University, Chandigarh without

assigning any reason. The lowest Tender will not necessarily be accepted.

17. No claim will be entertained in case these are over drawn/under drawn or even un-drawn.

18. Tenderers must not quote their own terms/mode of payment. Bank charges will be borne by the

Tenderers.

19. Any further information required can be had by submitting written request on any working day between

10 a.m. to 4 p.m. from the office of the Registrar Panjab University, Chandigarh.

20. Each and every page of the Technical Bid, Financial Bid and these Terms & Conditions are to be signed

by the Tenderer and returned with the Tender, Any omission in filling the columns or units & rates shall

altogether debar the Tender of Firm from being considered.

21. Conditional Tender, late Tenders, submitted otherwise as above shall be rejected.

22. In case of any dispute, the jurisdiction shall be at Chandigarh only.
