**“The machine has full control from driver’s seat with the help of LCD display, electromagnetic clutch for blade engagement and cutting height adjustment with 7 positions from 30-90 mm, powerful engine 650-700cc and cutting deck width 100-110cm, hydrostatic steering (HST) with adjustable comfort seat, 300-350 litre grass box capacity with two collecting mulching blades, Wheel sizes 15”-18”, engine power 10-12kw at 2500 rpm with battery charger, Noise levels upto 100 db  
Engine Make: - B & S/ Stiga/ Honda”**

3. Panjab University does not take any responsibility for any postal delay in delivery by Registered/Speed Post or lost in transit of the tender form. No tender will be entertained by hand/courier/ Ordinary post.
4. Rates should be quoted both in words and figures in tender.
5. Conditional and unsigned tender will not be accepted.
6. 2% earnest money of the total estimated cost worked out by the firm at par its rates will be deposited by the firm in the shape of Bank Draft in favour of **Registrar, Panjab University, Chandigarh** payable at Chandigarh alongwith its tender. Earnest money in the shape of CDR would not be accepted. Any bid not accompanied by required EMD will lead to rejection.
7. Approved tenderer will have to deposit 5% including E.M. of the total value of the items to be purchased in the shape of Demand Draft payable at Chandigarh in the name of “Registrar, Panjab University, Chandigarh” payable at Chandigarh within 7 days of issue of supply orders as security deposit.
8. Only original producers/companies or their authorized dealer/distributors having experience to supply similar type of product in the past can submit the tender.
9. Tender forms, specifications, terms and conditions can be obtained from this office on payment of Rs. 50/- in the shape of Bank Draft in favour of “Registrar, Panjab University, Chandigarh” payable at Chandigarh.
10. The supply be commenced/made within 45 days of the issue of supply order.
11. Items as supplied be warranted for quality for a period of one year of its supply against any manufacturing defects.
12. In case of any major defect, the item shall have to be replaced.
13. All quoted rates should be FOR Panjab University and rates quoted should be inclusive of all taxes, levies, octroi, insurance, cartridge, transportation, loading/unloading etc.
14. No payment will be made on the Performa invoice.
15. The tender/bid shall not contain corrections, erasers and overwriting.
16. Matters and disputes arising out of agreement between The Registrar, Panjab University, Chandigarh and the qualified tenderer shall be subject to the jurisdiction of the courts located at Chandigarh.
