#### **INSTRUCTIONS/TERMS & CONDITIONS FOR THE TENDERER**

**1.** Only manufacturers/distributors/suppliers of Dental Material & Lab. consumable are eligible to participate in the tender.

**2.** Documents once submitted will be considered as final. Any deficiency in the documents shall render the tender liable for rejection.

**3.** An affidavit, as per specimen enclosed as "Annexure-A" should accompany the tender. The tenderer who has been Black Listed or Debarred or his/her tenders/supply order have ever been cancelled or any legal proceedings have ever been initiated/pending or any penalty has ever been levied on account of delay or non completion of supply order by any State/UT/Central Govt., his/her tender shall be out rightly rejected.

**4.**Manufacturer authorization certificate, to be submitted along with the Tender, in the Technical bid envelop.

5. Technical Bid / Performa as per "Annexure-B".

6. The procedure to submit hard copy/Physical documents of Tender is as under:-

(i) First Envelop superscribed titled as **"Pre-qualification bid"** should contain EMD as per (Clause-8) of this Tender document & Non-Black-Listing affidavit i.e.**"Annexure-A"**.

(ii) Second envelop superscribed as **"TECHNICAL BID"**submitted in duplicate should contain the Documentary proof as per clause No.9 of this document.

(iii) Third envelop superscribed as **"FINANCIAL BID"** submitted in duplicate. Quote should be submitted for only those items which are ready to supply in the stock.

(iv) The financial bid shall not contain corrections, erasures or over writing unless attested by the tenderer with seal.

(v) All these three envelops shall be kept in another sealed envelope and submitted addressed to this office viz. "The Principal cum Professor, Dr. Harvansh Singh Judge Institute of Dental Sciences & Hospital, Sector-25, Panjab University, Chandigarh. The outermost envelop should be clearly superscribed "Tender for Dental Material & Lab. consumable due on 25.10.2013 at 3.00 p.m. All the envelopes should bear the name and postal address of the Tenderer and shall bear the address of this Institute as given above.

**7.**Tender will be opened in two parts/stages. Firstly, Pre-qualification bid shall be opened on 25.10.2013 at 3.30 p.m. If documents therein are as per the terms and conditions of Tender document, then only Technical Bids will be opened. Financial Bids of only those bidders shall be opened who will qualify in the Pre-qualification bid and technical bid. Any discrepancy in the documents will lead to rejection of the tender right away. The date and time for opening of Financial bid shall be intimated later.

#### 8. EARNEST MONEY DEPOSIT

Rs. 10,000.00 up to 05 Lac approx value of bid Rs.20, 000.00 up to 10 Lac approx value of bid Rs. 25,000.00 for 11 Lac & above value of bid

(i)EARNEST MONEY TO BE PAID IN THE SHAPE OF BANK DRAFT, DEMAND DRAFT, FDR, DEPOSIT-AT-ALL RECEIPT from any scheduled Bank in favour of "Principal-

cum- Professor, Dr. Harvansh Singh Judge Institute of Dental Sciences & Hospital, Sector-25, Chandigarh" which should be valid for One year.

(ii)The EMD of unsuccessful tenderers will be refunded immediately after finalization of the tender. No interest will be payable on EMD. The EMD will be forfeited, if the Tenderer withdraws his/her bid after submission of the Tender. No Tender without EMD shall be considered.

9.**TECHNICAL BID**: The tendering Companies/Firms/Agencies are required to submit self attested photocopies of the following documents, failing which their bids, may summarily/outrightly be rejected and will not be considered any further:-

(i)Name of the firm/Organization & Address and Telephone/Mobile/Fax no. and following check list of enclosed documents (on the Letter Head of the Firm).

(b) Whether copy of Sales Tax/VAT Registration Certificate attached? Yes/ No

(c). Income tax clearance certificate/Income tax return of last year attached? Yes/ No

(d) Attested photocopy of PAN Card, VAT No. & CST attached? Yes/ No

(e)Whether Sample whenever required, /Catalogue/Technical literature and brochures are attached as per (Clause-10) of this Tender document? Yes/ No

(f)Whether undertaking for the acceptance of the Terms & conditions as per format at pageNo.7 attached? Yes/ No

(g) All pages to be page numbered properly and stamped & signed? Yes/No

(h) Whether authorizing certificate from the manufacturer attached ?Yes/No

**10.** The Financial Bid of only those bidders will be opened who qualify in the prequalification and technical bid by the Purchase & Technical Committee.

**11. Sampling:** The samples required for the items as per "Annexure-B" should be sent in sealed Envelops by mentioning clearly as "SAMPLES", and the name of the tendere. The samples should accompany the main envelop.

(i) There should be no price tag on the samples otherwise samples will be rejected straight a way.(ii) The Catalogue, brochers and Technical literature of the items as per "Annexure-B" may be submitted in the sealed envelope of Technical specifications.

(iii) The samples of unsuccessful tenderers will be refunded immediately after finalization of the tender and to successful tenderers after completion of supply order.

**12.** The competent authority reserves the right to accept or reject any sample/tender without assigning any reason.

**13.** The rates quoted should be F.O.R destination within the Territorial limits of Panjab University, Chandigarh including packing, forwarding, postage, taxes/VAT, levies, Octroi, Insurance, Cartridge, Transportation, loading, unloading, freight etc.The expiry date of items should be minimum of Six months from the date of billing. Rates quoted shall remain valid for one year from the date of submission of the Tender.

**14.** The acceptance of tender will have binding effect on the tenderer and he/she has to supply the tenderered items/ordered items within the period stipulated in purchase order. Subletting of contracts shall not be allowed under any circumstances.

**15.** Security Deposit: As per "Annexure-C" the successful tenderer will have to deposit security/bank guarantee @ 10% of the total supply order value within 15 days of issuance of

letter of intent by the undersigned and the security deposited in connection with any other similar tender will not be considered against this tender. Thereafter, the purchase/supply order will be issued. If successful tenderer fails to submit requisite security deposit within prescribed 15days, Earnest Money will be forfeited and the supply order will be liable to be canceled.

16. Each item to be supplied by the successful tenderer should bear the <u>Stamp of "NOT FOR</u> <u>SALE P.U.CHD.SUPPLY"</u>.

**17. Inspection of Material:** Any person deputed by the Prinicipal-cum-Professor of the Institute will inspect/match the materials goods supplied by the tenderer in response to the purchase order. The Institute reserves the rights to reject the material, if same are not matched with the sample/technical specification/broachers etc.which has already been approved by the Committee.

**18.** Supply of ordered material & payment: The successful tenderers should supply the material as per the time schedule fixed by the Principal-cum- Professor Dr. Harvansh Singh Judge Institute of Dental Sciences& Hospital, Sector-25, Chandigarh from the date of placing the supply orders and in the event of finding the goods in order after inspection, the payment will be released accordingly.

**19.**The competent authority reserves the right to increase or decrease the quantity of the supply order.

**20.**The timely delivery/dispatch as stipulated in the supply order has to be strictly adhered to by the tenderer and in case of any request for extension of time made by the said tenderer in writing, the same be considered by the competent authority subject to the payment of penalty as provided in the terms & conditions of the tender.

**21.PENALTY:** (i)The competent authority reserves the right to impose penalties in the following exigencies:- In case tenderers fails to complete the supply within time period, then penalty @ 2% per week and not more than 10% of the total value of the supply order on the value of delay portion of supply will be levied. However, competent authority may relax the penalty clause if reason for the delay is found to be genuine.

(ii). In case, there is any variation in the specifications/samples approved vis-à-vis the supply received, then that portion of supply will be rejected and the tenderer shall be liable to supply the goods as per specification within a period of three days along with the penalty as imposed by the competent authority.

(iii). In case of defected supply, the supplier will be informed to lift the said supply within 5 days from the date of issuance of said letter by the competent authority, at his own cost. In the event of non lifting of said defective goods within the specified period by the tenderer, the competent authority will not be responsible in any manner for the loss or damage if any, caused to the said goods. The competent authority also reserves the right to impose any penalty as deemed fit in case the said goods are not lifted after the expiry of specified period.

**22. FORCE MAJEURE:** If the performance in whole/part by the party is prevented/delayed by any one or more of the force majeure events including but not limited to war, hostilities, civic commotion, acts of public enemy, sabotage, fire, floods and other natural causes, explosion, epidemics or non-availability of government controlled raw material under order/instruction of Central/State Govt. regulations, strikes, lockouts, agitations, embargo, act of civic or limitary authorities, the party shall not made liable for the loss of damage due to delay or failure to perform during the occurrence of force majeure event provided that the happening is notified in writing (with documentary proof) within 7 days from the date of occurrence. The work shall be resumed as soon as practicable after the force majeure event ceases to exist.

**23.** The Tender should be submitted by 3.00 pm on 25.10.2013 and the same will be opened on 25.10.2013 at 3.30 pm., by the Institutes Technical/Purchase Committee in the Committee room of the Institute in the presence of the tenderer or his/her authorized representative. In the event of the date of receipt or opening of Tender being declared a holiday, the due date of receipt/opening of the Tender will be the next working day at the same hours.

**24.** The Tender document is non-transferable.

**25.** The rates will be accepted on the distinctive understanding that these are not charged higher than those charged from the DGS&D rates and other Govt. Departments as on date, in the UT, Chandigarh. No price revision will be accepted by the competent authority during the currency of the Purchase Order.

#### 26. BLACK LISTING OF THE TENDERER:

(i)Tenderer participating in the tender and short listed after due processing of tender can be black listed, as per the Finance Department, Chandigarh Administration Notification No.1927-F&PO(3)-2009/1170 dated 27th February, 2009 for non fulfilling the requisite requirements of the tender documents/supply order or for concealing any information or for furnishing any false documents/statements in the tender.

(ii) Tenderer are expected not to indulge in any corrupt and fraudulent practice. They are expected to observe the highest standard of ethics during the procurement and execution of the Contract.

**27. ARBITRATION:** In the event of any dispute or difference the same shall be referred to the sole arbitrator i.e. the Principal-cum- Professor, Dr. Harvansh Singh Judge Institute of Dental Sciences & Hospital, Sector-25, Chandigarh, whose decision shall be final and binding on the parties thereto. The Arbitration & Conciliation Act, 1966, deemed to have come into force on 25.1.1996 shall apply to the said arbitration proceedings. The Expression/ Tender "The Principal-cum- Professor, Dr. Harvansh Singh Judge Institute of Dental Sciences & Hospital, Sector-25, Chandigarh" shall include an acting/officiating Principal-cum- Professor, Dr. Harvansh Singh Judge Institute of Dental Sciences.

**28.JURISDICTION:** The courts at Chandigarh alone will have the jurisdiction to try any matter, dispute or reference between the parties arising out of this Agreement/contract. It is specifically agreed that no court outside and other than Chandigarh court shall have jurisdiction in the matter.
