2. The applications for the issue of tender form will be accepted up to 07.04.2015 till 12:00 noon and the tender form will be issued up to 07.04.2015 till 4pm.
3. The tender must reach by **Registered Post or Speed Post before 15.04.2015 at 3.30 p.m.** on the following address:

4. The tenders will be opened in the meeting of JPC in presence of tenderers or their representatives who may like to be present at that time.
5. Panjab University does not take any responsibility for any postal delay in delivery by Registered/Speed Post or lost in transit of the tender form. No tender will be entertained by hand/courier/ Ordinary post.
6. The firm/contractor that has completed three works with equal cost of 40% value or the similar nature of work with one work in Govt. Deptt. or two works with equal cost of 60% value of the work or one work with equal cost of 80% value of the work, during the last seven years and furnishes the performance certificate for the same be eligible for issue of the tender form.
7. The tenderer must possess a license under the Contract Labour (Regulation & Abolition) Act 1970 to provide manpower. The Tenderer shall be responsible for compliance of all labour laws in respect of manpower provided and any other which may be applicable including payment of taxes etc.

8. The tenderer must have PAN and TAN numbers from last three years.
9. Rates should be quoted both in words and figures in tender.
10. Conditional and unsigned tender will not be accepted.
11. The tenderer should have independent E.P.F /ESI No. of the Govt.
12. 2% earnest money of the total estimated cost will be deposited by the firm in the shape of Bank Draft in favour of **Registrar, Panjab University, Chandigarh** payable at Chandigarh alongwith its tender. Earnest money in the shape of CDR would not be accepted. Any bid not accompanied by required EMD will lead to rejection.
13. Tender forms, specifications, terms and conditions can be obtained from this office on payment of Rs. 500/- in the shape of Bank Draft in favour of "Registrar, Panjab University, Chandigarh" payable at Chandigarh.
14. The tender/bid shall not contain corrections, erasers and overwriting.
15. Matters and disputes arising out of agreement between The Registrar, Panjab University, Chandigarh and the qualified tenderer shall be subject to the jurisdiction of the courts located at Chandigarh.
16. The contractor should mention name of work and due date on the Envelope.
