1. Tender form will be issued to only eligible tenderers and for this:
 - a. Application for issue of tender form will be accepted upto **24.06.2020 at 5.00 p.m.** only.
 - b. Bank receipt of tender fee and Bank draft of earnest money in favour of Registrar, P.U. Chandigarh will be deposited by the eligible firms for issue of tender upto **25.06.2020 at 1.00 p.m.** only. Tender shall be issued upto **5.00 p.m 25.06.2020.**
 - c. The tender form will be received by the undersigned in his office on **26.06.2020 upto 3:30 p.m** and opened at the same time in the presence of the tenderers or their representatives who may like to be present at that time. In case of holiday, tender will be opened on next working day.
2. The detailed Notice Inviting Tender can be seen in the office of the undersigned at any time during working hours.
3. Tender form can be had from this office by depositing **Rs. 50/-** in the shape of S.B.I. Receipt/ Banker Cheque and demand draft in favour of the Registrar, Panjab University, Chandigarh.
4. The contractor should quote only percentage rate.
5. The firm that have completed three works with equal cost of 40% value of the similar nature of work with one work in Govt. Deptt. OR two works with equal cost of 60% value of the work OR one work with equal cost of 80% value of the work, during the last seven years and furnishes the performance certificate for the same shall be eligible for issue of the Tender form.
6. The Contractor/Firm will submit tender application along with copies of EPF no., GST, Pan Card, Partnership Deed (if applicable).
7. Conditional tender will not be accepted.
8. The undersigned has right to accept or reject any or all the tender without assigning any reason.
9. The tenderer shall have to furnish an affidavit as under:-
 - a. *I/We hereby declare that*
 - b. *I/We have not been black listed, debarred/ suspended by any Govt., Semi-Govt./ Corporation/ Private Organization during the last 7 years.*
 - c. *I/We have not been penalized for non performance of contract agreement during the last 7 years.*
