 - b. Bank draft of earnest money in favour of Registrar, P.U. Chandigarh will be deposited by the eligible firms for issue of tender upto **29.11.2022 at 1.00 p.m.** only. Tender shall be issued upto **5.00 p.m. 29.11.2022.**
 - c. The tender form will be received by the undersigned in his office on **30.11.2022 upto 3:30 p.m** and opened at the same time in the presence of the tenderers or their representatives who may like to be present at that time. In case of holiday, tender will be opened on next working day.

4. Rates should be quoted both in words and figures in tender.
5. The firm that have completed three works with equal cost of 40% value of the similar nature of work with one work in Govt. Deptt. OR two works with equal cost of 60% value of the work OR one work with equal cost of 80% value of the work, during the last seven years and furnishes the performance certificate for the same shall be eligible for issue of the Tender form.
6. The Contractor/Firm will submit tender application along with copies of GST, Pan Card, Partnership Deed (if applicable).
7. Conditional tender will not be accepted.
