1. Tender form will be issued to only eligible tenderers and for this :
  - a. Application for issue of tender form along with earnest money in the shape of bank draft & Bank receipt of tender fee in favour of Registrar, P.U. Chandigarh will be deposited by the eligible firms for issue of tender upto 5.00 p.m. on **21.12.2022**
  - b. The tender form will be received by the undersigned in his office on **22.12.2022** upto 3:30 p.m. and opened at the same time in the presence of the tenderers or their representatives who may like to be present at that time. In case of holiday, tender will be opened on next working day.
2. The detailed Notice Inviting Tender can be seen in the office of the undersigned at any time during working hours.
3. Tender form can be had from this office by depositing Rs.100/- in the shape of S.B.I. Receipt/ Banker Cheque and demand draft in favour of the Registrar, Panjab University, Chandigarh.
4. The firm that have completed three works with equal cost of 40% value of the similar nature of work with one work in Govt. Deptt. OR two works with equal cost of 60% value of the work OR one work with equal cost of 80% value of the work, during the last seven years and furnishes the performance certificate for the same shall be eligible for issue of the Tender form.
5. The Contractor/Firm will submit tender application alongwith copies of G.S.T. No., PAN No., EPF No., Mobile No., e-mail i.d., Office address etc Partnership Deed (if applicable) & Enlistment of the firm.
6. To become eligible for tendering the tenderer shall have to furnish an affidavit as under:-
  - a) That I/We hereby declare that I/We have not been black listed/debarred/suspended by any Govt./Semi Govt./Board/ Corporation/Private firms as on last date of receipt of tender.
  - b) That I/We undertake and confirm that eligible similar work (s) has / have not been executed through another contractor on back to back basis. Further, it is undertaken that if such a violation comes to the notice of Construction Office P.U. Chandigarh then I/We shall be debarred from tendering in Construction Office P.U. Chandigarh in future forever. Also, if such a violation comes to the notice of Construction Office P.U. Chandigarh, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money/Performance Guarantee deposited by me/us.
  - c) That the deponent further undertakes that he/she/Director(s) /Partner(s) of he proprietor/firm/company/agency have never been convicted of any criminal offence.
  - d) That I/We also undertake that the particulars given by me are true and correct to the best of my knowledge and belief and nothing has been concealed there of I am aware that in case any discrepancy / false statement if found, it will lead to rejection of my bid/tender and the Construction Office P.U. Chandigarh will debar/blacklist the proprietorship/firm/company/agency as per policy of blacklisting issued by Chandigarh Administration vide notification dated 27.02.2009
8. Conditional tender without earnest money will not be accepted.
