- a. Application for issue of tender form will be accepted up 11.01.2023 at 5.00 p.m. only.
- b. Bank receipt of tender fee and Bank draft of earnest money in favour of Registrar, P.U. Chandigarh will be deposited by the eligible firms for issue of tender upto 1.00 p.m. only and tender shall be issued upto 5.00 p.m. on 12.01.2023
- c. The tender form will be received by the undersigned in his office on 13.01.2023 upto 3:30 p.m. and opened at the same time in the presence of the tenderers or their representatives who may like to be present at that time. In case of holiday, tender will be opened on next working day.

Chandigarh, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money/Performance Gurantee deposited by me/us.
